History of Freiburg University:

University Library Freiburg is one of the largest academic libraries in Europe. It supports the research, teaching and study conducted at the Albert Ludwigs University of Freiburg by providing and imparting literature, other media and information promptly and as needed.

Holdings

The University Library currently holds more than 3 million works in the humanities fields. A further 2 million volumes are available in the peripheral libraries. The University Library's historic collections include an extensive range of manuscripts, literary remains, incunabula and prints dating back to the 16th and 17th centuries, which are increasingly being digitised and made available online.

Moreover, the University Library is constantly expanding its widespread collection of ejournals, e-books and databases. In addition, the library's media centre is home to an extensive collection of audiovisual materials, which can be used for academic purposes.



Digital library

In the Digital Library we offer you a variety of electronic media such as databases, ejournals, e-books and other online publications. Whether you want to research bibliographic databases, read specialist articles in e-journals, find out more in current daily newspapers or view our historical holdings on the screen, you will always find valuable information for study and research in our digital library. You can use the wide and constantly growing online offering conveniently and free of charge on your computer via the university network.

Databases

Take advantage of our wide range of databases in all specialist fields. Choose between a number of database types, e.g. bibliographic databases, full text databases, fact databases and image databases.

The Database Information System (Datenbank-Infosystem / DBIS) holds our entire range of databases, including databases licensed to the University of Freiburg and freely accessible online databases. Search for a specific database title or browse the list of databases in your specialist field.

Katalog plus holds all databases licensed to the University of Freiburg.

E-journals Read and work online.

Find out more about our extensive range of e-journals. If you are a member of the University of Freiburg, you can access the e-journals from anywhere, otherwise you can access this service from our public computers in the University Library.

The Electronic Journals Library (EZB) is a national directory of journals available online. Most works are uploaded in full-text format. The traffic-light system indicates which texts are available in full.

Reading room holdings

The reading rooms are home to more than 230,000 volumes. You will find encyclopaedias, dictionaries, bibliographies, compendiums, editions; in short: basic literature for all subject areas.

Arranged by subject

The holdings in the reading rooms (LS) are distributed across four floors and arranged by subject area. Within this system, the books are systematically sorted into subfields.

You can walk along the shelves and pull out newly discovered titles or go to your favourite places to search for something specific. An outline of the books hangs from each shelf unit. Or you can look up the reading room classification system online.

You will find some journals within the subject areas held in the reading rooms.

All of our journals, including many electronic journals, are listed in Katalog plus.

Daily and weekly newspapers Discover our wide range of newspapers, both on paper and in electronic format.

Our selection of the latest newspapers, both domestic and international, is available in Reading Room 1. The issues from the past 6 to 8 weeks are displayed in alphabetical order.

You can find all of our newspapers, including many electronic newspapers, in Katalog plus.

Media archive

They have an extensive collection of audiovisual media for your teaching and research requirements:

- More than 22,000 VHS tapes and DVDs (feature films, film adaptations, theatrical productions, portraits, documentaries)
- More than 16,000 audio cassettes and CDs (music, audio dramas, readings) Refine the search results in Katalog plus to video/DVD or audio media types to specifically find audiovisual media.

they are happy to make digital recordings of our holdings. The technical equipment in our digitisation centre enables us to:

Scan source material of up to A1 in size (594 mm x 841 mm) at a resolution of max. 600 ppi and a colour depth of up to 24 Bit.

Photograph documents of up to A2 in size using a digital camera (max. 21 MP).

Make copies of microfilms and microfiches. We cannot provide scans or print-outs of microforms.

Handling the source material with care is our top priority, which limits us in many cases. We also need to observe legal restrictions. We will complete your order as long as it is feasible from a technical, organisational and conservational perspective. We will publish the reproductions in our digital library.

Placing orders

We can order digital reproductions online. To do this, search for the title you need in Katalog plus and reserve a copy in the "Holdings info" tab.

Prices and fees

Creating reproductions is time-consuming and costs money. The prices and fees for reproduction services apply.

Using, citing and publishing material

If you have questions about using our reproductions, please refer to University Library Freiburg's terms of use for digital content. If you plan to use them in a publication, please check how to correctly cite the works. In some circumstances, you may need permission to publish. We would be delighted to receive a deposit copy of your publication.

interlibrary loan and document delivery services

Over 4 million media in the university library, almost 2 million media in the institute libraries - yet some things are not available in Freiburg.

To ensure that you are adequately equipped for research and teaching, training and further education, we offer you the option of interlibrary loans. Regardless, you can always use a document delivery service. We present these offers here.

Order

After searching you can order directly. Please note that not everything you find in the interlibrary loan portal can be delivered.

Your order is for one volume or item. If you need more, please place an appropriate number of orders. To log in, use your library account number as your user ID and password. Members of the University of Freiburg use their university account.

We charge a processing fee of EUR 1.50 for each order. It is independent of the actual delivery. You can view your open orders and fees at any time in your UB account.

Delivery

An order is usually delivered after one to three weeks. For works that we cannot find directly in another library, the processing time may be slightly longer. As soon as we receive your order, we will notify you by email.

If your order is not available, you will also receive an email from us. This can have various reasons. We may just have a question for you - please answer us by email or telephone or stop by the information desk.

Pick up and drop off

You can pick up your interlibrary loan order at the information desk. You have until the end of the loan period to do this. We will inform you of the deadline by email.

You can borrow books delivered to your home or use them in the reading rooms - the library owner decides on this. Return them to the information desk later. You can keep copies.

Extend

Interlibrary loans usually have a loan period of 28 days and can be extended once. We offer this service to you subject to reservation. If the owning library needs a work itself, you will receive an email from us. In this case, please return the interlibrary loan as quickly as possible.

Some libraries give us a fixed loan period when they deliver interlibrary loans. Unfortunately, you cannot extend these media.



Scan service

Multiplication and conveyance of digital copies is only carried out for noncommercial purposes and to support academic education as well as scientific research. Information Serviced

Our division is called "Reader' and information services". We have two departments: "loan department/closed stacks" and "information services".

The information services have 10 colleagues (10 full-time positions), all librarians with several years of studies.

Our working hours vary and usually include up to 8 hours a day (between 7 o'clock and 8 pm).

On Saturdays one of us has to be here between 10 o'clock and 2 pm (in combination with colleagues of other departments). Every colleague has about 3 Saturdays in 5 months.

Visiting to Reading Room Department Tubingen Library

The debate about the library as palace of learning often focuses on student work and information needs .these ,however .usually represent highly selective requirements which do not reflect the full breadth of the library's rich offer of products and services .yet is it not the case that advanced .skilled usage .in terms of the scientific level .technical demands and information requests requires and seeks just such a place ,and one which could be

upgraded using appropriate services .thus Tubingen university library strives to provide a contemporary solution for science in access areas .

In 2013 will be integration between the Department of Information Center and the Department of reading rooms in one section only because students are asking here about the same questions by virtue of their proximity to the books and ask about books and so on.

Hold meetings to discuss what it takes to merge and what problems they will face. Of the most commonly asked questions from students is difficult to reach places in the library.

History of the University of Ulm

The University of Ulm is chronologically the ninth in Baden-Wuerttemberg. The first ideas of founding a university in Ulm go back to the 50's. In 1959, the research group "University of Ulm" was formed, which produced a memorandum on founding a university in March of 1961. Due to competition between the cities of Constance and Ulm in the early stages, the idea of establishing a university in each of the two cities gained popularity. A critical factor leading to this decision was the fact that Constance is situated near a federal border. The opportunities for employment in the field of medicine would not be sufficient due to the lack of a patient catchment area at the border. The idea of founding a university in Ulm therefore became more concrete - it would be a university shaped by medicine and natural sciences.

In July of 1965, the foundation committee submitted its "Memorandum on a College of Medicine and Natural Sciences in Ulm," which was approved by the

state of Baden-Wuerttemberg's council of ministers in January 1966. Just two months later, the "Interim Constitution of the Ulm College of Medicine and Natural Sciences" came into effect.



Who is kiz?

The Communication and Information Center (kiz) is a central service provider for the University of Ulm, which, as defined in §28 LHG (University Law of the State of Baden-Württemberg), was established to maintain a literature collection that supports the study, teaching, and research needs of the University community as well as to handle the planning, management, operation, and maintenance of the University's ICT resources. After its founding in 2002, kiz took over operation of the University Library, University Data Processing Center, and the Photography, Graphics, and Reproduction Center.

Databases

In many cases, access to databases is not for free but rather purchased through license agreements.

In order to use the Library's licensed electronic resources, a campus network IP address is required. You can connect to the network via landline or Wi-Fi (off campus via VPN).

Alternatively, access to a growing number of resources is now available via Shibboleth. This authentication/authorization system grants the library user access to licensed resources, such as e-journals, databases, and e-books, from outside the University network. Simply login via EZB, DBIS, REDI, or directly via the service provider's website (publishing house, scientific society, etc.). If you encounter the terms Athens or DFN/AAI in a login context, they also refer to Shibboleth login functionality.
